Technical Competencies

 A university degree in a relevant discipline and a degree and/or certificate in Environmental Sciences, Environmental Engineering, and Environmental/Resource Economics, Community Development, (Inclusive) Disaster Risk Management or other related fields will be an added value.

- A minimum of eight (8) years' relevant experience working in the area of environment, sustainable development, rural development, natural resource management, community development-<u>plus disaster risk /reduction/management is a MUST</u>- including at least five (05) years' experience with Project Management responsibilities.
- Significant experience of community disaster risk reduction projects in coastal areas of Sindh with inclusion approach.
